- OLM:Oracle monitors your virtual machines running Oracle to ensure that they stay in defined licensed environments
- If those VMs move, either automatically or manually, to a non-licensed environment, OLM:Oracle will flag the event, and update the user dashboard

Use of Unlicensed Database Features

- **Oracle leaves all of their database options and packs enabled by default**

- OLM:Oracle automatically monitors and flags each Oracle database in the cloud or on-premises to determine if any features start being used for which the user does not have a license
